I/We agree that should there be insufficient funds in my/our account to meet any transfer hereby authorised, my/our Bank shall be entitled, in its discretion, not to effect such transfer in which event the Bank may make the usual charge and that it may cancel this authorisation at any time on one week's written notice.

This authorisation shall have effect until further notice.

I/We agree that any notice of cancellation or variation of this authorisation which I/we may give to my/our Bank shall be given at least two working days prior to the date on which such cancellation/variation is to take effect.

利用自動轉帳系統繳交差餉及／或地租

AUTOPAY FACILITY FOR PAYMENT OF RATES AND/OR GOVERNMENT RENT

注意事項

- 自動轉帳系統並不適用於繳交「首次徵收差餉及／或地租通知書」。
- 由於處理自動轉帳授權書需時，繳納人必須採用「徵收差餉及／或地租通知書」背頁所示的其他繳款辦法繳交差餉及／或地租，直至所收的繳款通知書上印有自動轉帳的訊息。
- 差餉及／或地租須在每季的第一個月份內繳交。如在最後繳款日期後仍未繳交，則會加徵百分之五的附加費。如在繳款限期過後六個月仍未繳交，則在所欠的差餉及／或地租（連同先前的附加費在內）再加徵百分之十的附加費。
- 差餉及／或地租繳納人的資料如有任何改變，繳納人必須通知本署。

Important Notes

- Autopay facility is not applicable to "First Demand for Rates and/or Government Rent".
- As it takes several weeks to process an autopay authorisation, rates and/or Government rent should be settled by other methods of payment as indicated at the back of the quarterly demand notes until the autopay message is printed on the demand.
- Rates and/or Government rent are payable quarterly in advance during the first month of each quarter. A surcharge of 5% may be imposed if payment is not made on or before the last day for payment. A further surcharge of 10% may be imposed upon such rates and/or Government rent (including any surcharge already imposed) remaining unpaid six months after the last day for payment.
- Rates and/or Government rent payers are responsible for notifying this department of any change in payer's particulars.

個人資料

- (1) 你所提供的資料將會給予你的銀行及差餉物業估價署，用作處理你的自動轉帳繳付差餉及／或地租的申請。
- (2) 除上述用途外，你所提供的個人資料將不會給予其他人士，除非該些人士獲法例授權而要求取得這些資料。
- (3) 根據《個人資料（私隱）條例》的規定，你有權要求查閱及修正你的個人資料。

自動轉帳的優點

- (1) 款項只在最後繳款日期當日才過戶，**不會提早扣除**。
- (2) 付款永不過期，因此毋須擔心被加徵附加費。
- (3) 既方便，又可節省資源。

Personal Information

- (1) The information provided by you will be used by your Bank and the Rating and Valuation Department to process your application for direct debit payment of rates and/or Government Rent.
- (2) Apart from the purposes stated above, the personal information provided will not be transferred to any other parties, unless such parties are authorised by law and request the information.
- (3) Under the Personal Data (Privacy) Ordinance, you have a right to request access to and correction of your personal data.

Benefits of Autopay

- (1) Autopay debits are made only on the last day for payment, **not earlier**.
- (2) There will be no overdue payment, hence no surcharge.
- (3) It is not only convenient, but also saves resources.

注意事項（續）

- (5) 如載於徵收通知書上的登記繳納人姓名已更改（包括修改英文拼法；以中文姓名取代英文姓名或英文姓名取代中文姓名），或物業的差餉及／或地租估價已被刪除，此直接付款授權書即自動失效。
- (6) 因差餉及地租額會隨每次重估差餉／改變差餉率而調整，故不宜在自動轉帳預設授權轉帳限額。
- (7) 每季的差餉及／或地租額即使有變，差餉及／或地租繳納人亦毋須辦理另一直接付款授權書。
- (8) 本署收到某一物業單位重新遞交的直接付款授權書後，該物業單位以往遞交的所有授權書即一概失效。
- (9) 如以銀行直接付款方式繳款，將不發收據。
- (10) 如在填寫直接付款授權書上遇有任何困難或對以自動轉帳繳付差餉及／或地租及其生效日期有任何疑問，請與本署聯絡（電話號碼：2152 0111（由「1823」接聽），傳真號碼：2152 0113）。

Important Notes (Continued)

- (5) A change in the rates and/or Government rent payer's name (including amending the spelling; changing it from Chinese to English, or vice versa), or a deletion of the rating and/or Government rent assessment will automatically invalidate this direct debit authorisation.
- (6) Since rates and Government rent are adjusted from time to time following a General Revaluation / changes in the rates percentage charge, it is not advisable for you to set a limit on the amount authorised for autopay.
- (7) A further direct debit authorisation will not be required if the amount of quarterly rates and/or Government rent demanded has been changed.
- (8) On receipt by this department of a fresh authorisation in respect of a tenement, all previous authorisations for that property will be invalidated.
- (9) For payments made by direct bank debit, no receipts will be issued.
